NORTH AMERICAN SWISS ALLIANCE EXCERPTS OF NATIONAL CONVENTION MINUTES - MAY 11, 2018

President Alois Amstutz called the teleconference meeting to order at 11:05 am. President Amstutz stated Lynn Kosin would serve as Recording Secretary.

Vice President Donald Robison offered an opening prayer for guidance and meaningful discussion. He asked for blessings on all directors/delegates and for the wisdom and strength to do what is best for the future of the North American Swiss Alliance. VP Robison asked all to remember those directors who have passed since the last convention:

Ernie Bollinger (October, 2014) – Elected as NASA Director in 1958 and Vice President in 2006. Retired 2010.

Ferd Reichlin (September, 2017) – Elected as NASA Director/Advisory Officer in 1991. Retired in 2010. Kurt Ottiger (February, 2018) – Elected as NASA Director in 1970, Vice President in 1978, and President in 1990. Retired in 2006.

CREDENTIALS - President Amstutz announced the Executive Board reviewed credentials of all Delegates and all was in order.

ROLL CALL - Marilyn Kozma resigned as a Director effective April 26, 2018. Director Richard Hardt was unavailable during tele-conference. The following were participants on the call: EXECUTIVE BOARD: President Alois Amstutz, Vice President Donald Robison, Secretary/Treasurer Jan Markowski, Advisory Officer Kevin Ruedy; DIRECTORS: Darlene Kilchenmann, Carl Kunzler, William Preslock.

MINUTES OF LAST CONVENTION - All Directors and Delegates received a copy of the minutes from the last convention held May 16, 2014 via teleconference. Minutes were also published in The Swiss American. Donald Robison made a motion to accept the minutes as written, seconded by Jan Markowski. Motion passed.

COMMUNICATION AND PETITIONS - There were no petitions presented before the convention.

PRESIDENT ALOIS AMSTUTZ'S REMARKS

Beginning with the calendar year ending 12/31/10, the Ohio Department of Insurance began requiring annual Cash Flow Testing for all insurance companies licensed in more than one state. The cost to the Alliance is approximately \$14,000 per year. Our actuary, Grant Hemphill, has worked closely with Peter Weber, Ohio Department of Insurance to reduce the frequency of this testing which was updated in 2017. Previous full cash flow testing was completed in 2014. Also, the State of Ohio has granted our request for outside audit for the years ending 2014, 2015, 2016, and 2017.

Since we last convened, three former members of the Executive Board have passed. Ernie Bollinger in 2014, Ferd Reichlin in 2017, and Kurt Ottiger in 2018. The contributions from each of these gentlemen have guided the Executive Board over the years.

As reported at the 2014 Convention, Ohio House Bill 341 requires fraternal organizations like the North American Swiss Alliance who write policies with up to \$10,000 in death benefits to maintain surplus of \$500,000 as of January 1, 2016. The Alliance continues to exceeds this requirement.

As part of the State's review of the Alliance (January 1, 2011 - December 31, 2014), we received a directive not to be overly dependent on members for decision-making. non-Board Separately, in 2016, the State of Ohio presented the CGAD (Corporate Governance Annual Disclosure) Model Act, which documented the need to ensure the Alliance's officers and key persons in control functions have the background, experience, and integrity to fulfill their respective roles. The critical areas include risk management processes, actuarial function, investment decision making processes, business strategy/finance decision-making compliance function, financial processes, reporting/internal auditing, market conduct decisionmaking processes. Number of Board members and their duties, as well as succession plan need to be documented. Initial submission is due June 1, 2018.

In compliance with the State's non-compliant findings at the conclusion of their review, effective January 1, 2017, the Alliance engaged Hudak & Vrana to prepare quarterly and annual statements in accordance with NAIC and the State of Ohio. John Vrana is proactive in his approach and provides excellent services.

In compliance with the State's non-compliant findings at the conclusion of their review, in September 2017, we transferred the custody our portfolio from a Pittsburgh-based investment advisor to Phil Hrvatin of Wells Fargo, located in Cleveland in order to provide the State will the required custody agreement which the Pennsylvania firm was unable to provide. Phil is experienced with the need for monthly income required by fraternal organizations and has provided valuable insight to the Alliance.

Kevin Ruedy was appointed to the Executive Board in June, 2017 to fill vacancy following resignation of Richard Rowland. Kevin is positive and upbeat and has been a solid contributor since his appointment.

The Akron Swiss Society closed. This society made a generous donation to North American Swiss Alliance. Policy members were transferred to the Central Branch and are maintained out of the National Office.

Transition to a new 2017 CSO Table is mandatory for new policies as of January 1, 2020. The executive board will work closely with our actuary, Grant Hemphill to ensure compliance. Rates are likely to change. The last change was effective with the 2001 CSO Table on January 1, 2009.

As part of the 2018 Convention, Delegates are charged with the responsibility of electing nine Directors to serve from July 1, 2018 to June 30, 2022. I am tendering my resignation as President of the Alliance at the conclusion of my term (June 20, 2018). I have enjoyed serving as President since 2006. It is imperative that those serving on the Board of Directors have the appropriate background, experience, and integrity to fulfill their respective roles, totally support the effort of the Alliance and continue to sell new policies.

SECRETARY-TREASURER JAN MARKOWSKI'S REPORT

Over the past four years, total policies in force have dropped in number from 2,164 in 2014 to 2,127 as of 12/31/17.

We are pleased to report our Annual Statements have shown an operating gain for five consecutive years. The gain range has been \$8,699-\$84,022 with an average of \$45,037. Ken Kabealo, State of Ohio, Department of Risk Assessment, is pleased with our financial situation.

Actuarial expenses have remained consistent over the past four years. With the engagement of Hudak & Vrana in 2017, we anticipate a slight reduction in reporting costs.

We continue to maintain our controllable expenses with a freeze on salaries and prudence in general expense spending. In addition, we have seen a significant increase in investment income over the past few years, a direct result of changes made in investment advisors.

The State of Ohio requires the Alliance to maintain a surplus minimum of \$500,000. Our

surplus as of December 31, 2014 was \$637,240. Our discretion in financial management has brought this figure to \$751,522 as of December 31, 2017.

The aging of our policy holders is reflected the death claims which are offset by new policies written. Regulations only allow the Alliance to accept new policy applications presented in California and Ohio (two states where licenses are held).

We continue to participate in quarterly conference calls with our Financial Analyst from the Ohio Department of Insurance and regular communication with our actuary and accountant. Via roll call, Recording Secretary Lynn Kosin asked each participant if there were any questions on the written reports they had received. No questions were asked.

GRIEVANCE COMMITTEE REPORT - Director Carl Kunzler stated there have been no grievances. Grievance Committee will be appointed by new Executive Board in July, 2018.

RECOMMENDATIONS OF THE **EXECUTIVE BOARD** - Delegates received a copy in the mail for review prior to the tele-conference. Via roll call, Recording Secretary Lynn Kosin asked each participant if there were any items which required discussion. No questions were asked. made а motion to accept recommendations as written (below), seconded by Jan Markowski. Motion passed.

BOARD OF DIRECTORS - Executive Board recommends no change, but that in compliance with required Corporate Governance Annual Disclosure, Directors should have the appropriate background, experience, and integrity to fulfill their respective roles. The critical areas include risk management processes, actuarial function, investment decision making processes, compliance business strategy/financial making process, market conduct decision-making processes. Succession plan includes appointment of persons with new, fresh ideas.

PER DIEM - A per diem is set to cover expenses incurred by the Directors/Delegates, other than transportation. The amount has varied due to location and cost of food and lodging, as well as the number of days and nights in attendance. In 2014, Board of Directors recommended eliminating per diem due to no overnight or meal expenses. Executive Board recommends no change.

DIRECTORS' MEETING FEE - The Directors' meeting fee set at the 2008 Directors' Meeting was \$160.00 per day. In 2014, Board of Directors recommended reducing to \$100 due to absence of travel. Executive Board recommends no change.

TRAVEL REIMBURSEMENT - Mileage is paid to the driver at current IRS rate (\$.545 per mile). Toll fees and parking are paid to the driver. Executive Board recommends no change.

RECORDING SECRETARY'S FEE - At the 2008 Directors' Meeting, the fee for the recording secretary was increased to \$200 per day. Recording Secretary is paid normal salary if meeting is held during normal workday. Executive Board recommends no change.

EXECUTIVE BOARD COMPENSATION

Executive Board recommends changes to the following four compensation categories as listed below. Reallocation deemed appropriate based on division of duties.

President's Salary - Currently \$925 per month; Vice President Compensation - Currently \$100 per month in addition to executive board meeting fee; Secretary Treasurer Compensation - Currently \$100 per month in addition to executive board meeting fee; Executive Board Meeting Fee - \$160 per meeting plus IRS mileage for each member who drives to the meeting.

RECOMMENDED COMPENSATION

President - \$600 per month plus IRS mileage; Vice President - \$400 per month plus IRS mileage; Secretary/Treasurer - \$500 per month plus IRS mileage; Financial Advisor - \$180 per month plus IRS mileage

THE SWISS AMERICAN - The Swiss American has been produced out of the office since June 2008. Executive Board recommends the publication schedule continue to be based on articles submitted and necessity of official notices.

BENEVOLENT MEMBERSHIP - Benevolent membership was established for people not eligible for life insurance so they could be affiliated with the North American Swiss Alliance and receive The Swiss American. Each branch society sets its own fee for local membership. Currently, we have approximately 202 benevolent members with \$10/year membership fee. Executive Board recommends no change.

DIVIDEND PAYMENTS - At 2010 Directors' Meeting the Executive Board was given authority to determine the rate of dividends paid based on the financial situation at the end of each calendar year. Executive Board recommends no change.

CONSTITUTION CHANGES - Executive Board recommends no changes.

NOMINATIONS FOR BOARD OF DIRECTORS - List of current nominees, with their qualifications, was sent to all Directors/Delegates prior to the meeting.

Recording Secretary Lynn Kosin read list of nominees. Directors/Delegates were advised if there were no nominations from the floor, the new Board of Directors could be elected by acclamation vote and there would be a vacancy on the Board until such time as a qualified person was identified. Via roll call, Recording Secretary Lynn Kosin asked for nominations from the floor for the Board term July 1, 2018 to June 30, 2022. There were no nominations. William Preslock made a motion to elect the current nominees by acclamation vote, seconded by Suzanne Sarasin. Motion passed.

New Board of Directors consists of David Stucki, Canton; Donald Robison, Canton (incumbent); Darlene Kilchenmann, Canton (incumbent); Jan Markowski, Cleveland (incumbent); John Jencson, Cleveland; Kevin Ruedy, Toledo (incumbent); Lynn Kosin, Cleveland; Thomas Vassallo, Cleveland.

Directors shall take office on July 1st following their election and term of office shall be four years per Article 6, Section 4 of the Constitution. Any vacancy in office on the Board of Directors or Executive Board may be filled by appointment by the Executive Board, subject to the approval of the Board of Directors, until the following regular convention per Article 6, Section 7 of the Constitution.

ELECTION OF EXECUTIVE BOARD - Nominating Committee recommended Jan Markowski as President; Donald Robison as Vice President; Lynn Kosin as Secretary/Treasurer; Kevin Ruedy as Financial Advisor. Via roll call Recording Secretary Lynn Kosin for additional nominations from the floor. There were none. William Preslock made a motion, seconded by Carl Kunzler, to elect by acclamation vote. Motion passed.

CLOSING REMARKS - President Alois Amstutz thanked everyone for participating and encouraged everyone to sell new policies, especially to younger people. Our policies are affordable and new policies help keep the Alliance in good financial standing. Vice President Donald Robison thanked Al Amstutz for his leadership. William Preslock stated the newly elected Board is well qualified and wished them success.

Director Carl Kunzler asked how decisions were made regarding donations. Per the Constitution Article 14, the Relief Fund is maintained by the Executive Board.

Kevin Ruedy made a motion to adjourn, seconded by Carl Kunzler. Meeting adjourned at 11:32 am.

Practiced among the alpine population since prehistoric times, it is recorded to have taken place in Basel in the 13th century. During the 15th century, it is frequently recorded to have been practiced alongside the Schützenfeste (shooting festivals) of the Old Confederacy. It is also central to Unspunnenfest near Interlaken, first held in 1805.

<u>Masskrugstemmen</u> – The goal is simple: Lift and hold a 1 liter stein, filled with beer, straight out with your arm level to the ground. And hold it there as long as you can! The current U.S. record is 14 minutes, 2 seconds!

Chow Down. Bottoms Up - From sauerkraut to schnitzel to strudel, the German-American Festival offers a savory selection of authentic German food to match any appetite. And you'll want to pair that delicious food with one of over 50 German beers.

Kurt was born in Lucerne, Switzerland in 1924 to Theodore and Elizabeth Ottiger. Kurt served in the Swiss Air Force during World War II. He graduated from the University of Geneva, Switzerland and later The University of Akron with a degree in International Finance. He came to the U.S. in 1948 to attend the University of Akron and lived at the YMCA while working as a dishwasher at Portage Country Club. He never intended on staying until he met Thelma Anderson at a dance at the Y. They married in 1951. He became a U.S. citizen in 1954. He

later worked for a CPA firm, a trucking company, and became a banker. He retired from National City Bank as Vice President of International Banking with 30 years of service. Kurt was President of the North American Swiss Alliance (1990-2006), as well as the Akron Swiss Society.
